## Section C-2 Leadership Scholarship

### Purpose

Section C-2 has a scholarship fund to help youth Arrowmen participate in Order of the Arrow leadership opportunities. The scholarship's sole purpose is to benefit any youth Arrowman who chooses to attend a National Leadership Seminar (NLS), any of the Order of the Arrow Trail Crew programs at a national high adventure base, or other national Order of the Arrow program of emphasis as staff.

### Scholarship Details

The number of scholarships will be determined from the funds derived from the sale of Section C-2 fundraiser patches, donations received, as well as any other funds set aside by the Section for the purpose of scholarships, with a goal of twenty (20) scholarships per year. No more than ten individuals from any one lodge will be allowed to receive a scholarship in any given year. As a National Leadership Seminar will be held in Michigan in 2013, additional scholarships may be made available if requests for scholarships exceed the annual allotment.

Scholarships will be given out on a first-come, first-served basis until the funds allotted for the scholarships have been awarded. Any funds remaining at the end of the calendar year will remain in the fund to be used in the following year.

Applications will be turned into the Scholarship Administrator (Associate Section Adviser) for review. Scholarships will be awarded once approved by the Associate Section Adviser, who will then direct the Section Staff Adviser to issue the scholarship to the lodge.

This scholarship is a matching grant scholarship, meaning that the section will match, up to \$75.00 or one third of the cost of the event, the amount of the grant awarded from the Arrowman's lodge or council. The combined scholarship/campership shall not exceed the total amount of the registration fee. Scholarships from the Section are awarded *after* the specified event has been attended by the Arrowman. In the case of a financial hardship for the youth, a greater amount may be considered, based on the situation.

It is encouraged that applicants have a commitment from the local council or lodge for partial funding, as consideration will be given to Arrowmen who have obtained funding from the lodge or the council as well.

### Application Requirements

1. Only BSA registered, dues paying youth Arrowmen may apply for a scholarship. A youth may not apply for more than one scholarship per calendar year, unless approved by Section Adviser.
2. To apply for a scholarship, applicants must submit to the Scholarship Administrator, a scholarship application completely filled out, which includes all required signatures.
3. Complete application must be submitted no later than 30 days after completion of event.

  - 3. Write about what he has learned about himself from the event and how that relates to his Scouting involvement.
  - 4. Explain how the Arrowman will be able to use his experience to benefit his lodge and troop.
- b. Attach a photocopy of the completed application for event scholarship is to be applied towards.
- c. Attach acknowledgement from either the council or the lodge stating what financial contribution has been made by the council or lodge in support of the Arrowman's leadership training.

**Required Signatures:**

- 1. Applicant's signature, acknowledging that he understands that he is responsible for the full cost of the event, less any council or lodge contribution, and that this application does not constitute a guarantee of financial award.
